**ADMISSION AGAINST VACANT SEATS, 2018**

B.A., LL.B.(HONS.) FIVE YEAR INTEGRATED COURSE

&

ONE YEAR LL.M. DEGREE PROGRAMME

- Candidates whose names have been enlisted in Annexure I &II are required to deposit a sum of **Rs. 50, 000/-** (Refundable) through NEFT/RTGS in favour of **NLUJAA, Fee Collection and Mess Dues Account No. 912020047748260 AXIS Bank Ltd., A.T. Road, Paltan Bazar, Guwahati IFSC Code - UTIB 0000375, latest by 16 July, 2018 ( 5.00 pm).**
- While depositing the **Seat Booking Fee (Rs. 50, 000/)** kindly ensure that the **name of the student is mentioned in the Bank Narration** for easy identification of the student on whose behalf the Fee has been deposited.
- After making the payment, candidates are required to email a **scanned copy of the transaction receipt (reflecting the UTR No.) of Rs. 50,000/** along with the candidates' name at [admissions@nluassam.ac.in](mailto:admissions@nluassam.ac.in). **Kindly note that a scanned copy of the transaction receipt of the Application Fee of Rs. 500 deposited at the time of application against vacant seats must also be emailed.**
- **The above-mentioned amount is only for booking a seat against the vacancies and does not assure a seat at the University. Seats will be allotted according to the availability of vacancies in each category. Shortlisting of candidates shall be done on the basis of CLAT ranking.**
- A confirmation mail shall be sent to the candidates (from among those who have deposited the Seat Booking Fee within the stipulated time frame) who have been allotted seats in the **B.A., LL.B.(HONS.) FIVE YEAR INTEGRATED COURSE/ LL.M. ONE YEAR DEGREE PROGRAMME** on **18<sup>th</sup> July, 2018**. Further, the procedure for admission shall be outlined in the email.

- In the eventuality that NLUJAA is not able to offer seat to a candidate who has deposited the amount of Rs.50, 000 to book a seat, the full amount shall be refunded to the same. However, should a candidate decide to withdraw his/her candidature after being offered a seat by the university, an amount of Rs. 25,000/- shall be deducted from the deposited amount.
- It may be noted that the process for fee refund shall be initiated after the closure of admission procedure i.e. July 26, 2018.
- A mail shall be sent to those applicants who have made the payment but have not been allotted a seat at NLUJAA, and the process for refund of the amount paid shall be initiated thereafter.
