

**INFORMATION ON ADMISSION OF INTERNATIONAL STUDENTS  
B.A.,LL.B. (Hons.) Five Year Integrated Course  
(2018-2019)**

National Law University and Judicial Academy has a few supernumerary seats reserved for international students (out of which 5% is earmarked for the children of Indian citizens working in the Gulf or South East Asian countries). Interested candidates may apply for the seats in the prescribed format on or before July 9, 2018.

**1. Eligibility:**

The candidate should have passed an examination recognised by the Association of Indian Universities, New Delhi as equivalent to Higher Secondary Examination (10+2) under Indian System securing not less than 45% marks in the aggregate.

2. Candidates who are appearing / have appeared in the qualifying examination are also eligible to apply for admission but they should submit their result of the qualifying examination on or before July 30, 2018.

3. Foreign Nationals are exempted from taking the Common Law Admission Test (CLAT). The admission shall be made on the basis of:

- i) academic record of B.L. / LL.B. or equivalent Degree recognized by UGC / Association of Indian Universities with not less than 55% marks or equivalent grade; and
- ii) assessment of necessary communication skills in written and spoken English and performance at the interview in terms of aptitude and capacity.

4. Candidates must enclose the following documents with the filled in Application Form:

- i) Copy of a valid Passport;
- ii) Copy of the marks statement of X Standard
- iii) Copy of the statement of marks at the Qualifying Examination (i.e. an examination equivalent to 10+2) along with equivalence certificate from Association of Indian Universities, New Delhi;
- iv) Percentage Conversion Certificate from the School / Board in case of Grades;
- v) Copy of Birth Certificate;
- vi) Demand Draft for Rs. 5,000/- drawn in favour of 'REGISTRAR, National Law University and Judicial Academy, Assam payable at Guwahati (name of the candidate should be written on the reverse side of the Demand Draft);
- vii) One passport size photograph must be pasted on the Application Form.
- viii) In case of NRI Sponsored Candidates, the Passport and Citizenship Certificate of the sponsor will have to be submitted
