- Interested candidates may apply against the aforementioned categories through the Online Application form available on [www.nluassam.ac.in](http://www.nluassam.ac.in) along with a **non-refundable Application of Fee of INR 500/-** to be paid through the NLUJA, Assam online payment portal <http://admissions.nluassam.ac.in>.
- The admission form link as well as the online payment link shall be available from **6<sup>rd</sup> July to 10<sup>th</sup> July, 2019 (till 5.00pm)**.
- After the receipt of applications, a Merit List (**based on CLAT, 2019 ranking**) of each Category will be published on **12<sup>th</sup> July, 2019**.

Candidates who would be **enlisted in the Merit List would have to deposit an amount of Rs. 50,000/-** latest by **17<sup>th</sup> July, 2019** to book their seats at NLUJA, Assam.

- In the eventuality that NLUJA, Assam is not able to offer seat to a candidate who has deposited the amount of Rs.50, 000/- to book a seat, the full amount shall be refunded to the candidate. However, should a candidate decide to withdraw his/her candidature after being offered a seat by the university, some amount shall be deducted from the deposited amount as per [NLUJA, Assam Refund policy](#). **In this regard it may be noted that the last day of admission for students who would have submitted applications against vacant seats is July 31, 2019.**
