Candidates who have been allotted seats at NLUJA, Assam are required to transfer **Rs. 84,500/-** as **Admission Fee** for Semester I through payment link provided **on or before 18/8/2021 (2.00 pm)**. (*Admission Fee for Semester II will have to be deposited at the commencement of the same*)

Note:

- 1. Candidates claiming seats in the reserved category are to submit Caste Certificates/Permanent Resident of Assam Certificate (PRC) /PWD Certificate/ OBC/MOBC (NCL) Certificate, whatever applicable.***
- 2. Candidates who have not paid the seat booking fee of INR 50, 000/ to the account of the CLAT Consortium, are to pay INR 1, 34,500/ to the University.***
- 3. Candidates who are not able to submit any ancillary documents (specified by the CLAT Consortium/NLUJA, Assam) will have to submit an Undertaking, in the format prescribed by the University and appended herewith as Annexure III). It is mandatory to submit all qualifying documents.***
