About Centre for Child Rights: Centre for Child Rights was established as a 'Centre of Excellence' for promotion of advanced research, teaching and study to address issues relating to children and child rights. It seeks to create awareness among the masses and support the state in implementation of the aims and objectives as specified in various International Human Rights Instrument with particular focus on Children and provisions as enshrined in the Constitution of India and various other legislation pertaining to children. UNICEF Assam State Office has joined hands with NLUJA, Assam through a Memorandum of Association signed and agreed between both parties to work together for addressing key issues in the area of child rights governance. One of the key Objective of the Centre is to work as an Observatory on Child Rights for North-Eastern States of Assam.

Objective: Centre for Child Rights in achieving in one of its objective will act as a Social Watch with an aim to analyse and monitor the present situation of children and ensure evidence based advocacy for creating awareness and influence decision making for creating better situations for children. Centre for Child Rights is looking for spirited interns and volunteers pursuing specialisation in Human Rights or possess an interest in Child Rights who are willing to dedicate their time to the Centre for this purpose.

The idea behind engaging volunteers/interns for the Centre is to give a qualitative exposure to students, orient them with policies and programmes supporting children's right and their protection, accoutre them with research skills and help them to gain an insight on issues and present scenario of child rights and protection in India, visive towards achieving the Centre's Objective to work as a Child Rights Observatory for North Eastern States including Sikkim.

Responsibilities:

1. Conduct media analysis, collect news/articles from internet and newspapers concerning child rights for all the north-east states and maintain a data base.
2. Assist in conducting qualitative and quantitative research based on primary and secondary data.
3. Assist in organising Conferences and Workshops.
4. Carry out primary level documentation work for the centre.
5. Assist in other works as decided by the Centre.

**Qualification:**

- For Students of National Law University, Assam: Students from any Year having a keen interest towards issue of Children and willing to work as a team can apply.
- Students from other Institution/College: Pursuing graduation in Law, Social Work, Sociology, Human Rights and other allied course related to Social Sciences. Pursuing Master's in Social Work, Sociology, Human Rights or any other allied subjects related to Social Sciences.

- The Internship does not constitute to an employment or does it guarantees employment after the completion of internship.
- Centre for Child Rights does not have an Internship allowance however all official cost incurred by you in the course of internship assignment including travel for official purpose will be reimbursed on actuals against bills/vouchers.
- Candidates interested for Internship with Centre for Child Rights may apply with their CV, filled in Application Form and Statement of Purpose by 25th of May, 2017.
- Internship Period – 1st June – 31st July
 - o Internship can be provided for a period of 2 Months, 45 Days or 1 month (minimum).
 - o Volunteership is provided all round the year. Minimum volunteering span will be 2 months.
