1. The rates should be quoted against the items/articles should be in prescribed format as mentioned in Price Bid Form.
2. The sealed envelope should be subscribed on top as "The Registrar, National Law University and Judicial Academy, Assam".
3. The Firm will have to deposit Earnest money of **Rs. 10,000/-** each in the form of Demand Draft in favour of "Registrar, National Law University and Judicial Academy, Assam".
4. The air conditioner must be of minimum 3 star BEE category.
5. Supplier have to make necessary arrangement for installation of outdoor unit of the air conditioner.
7. All the electrical component like MCCB, power plug, electric wire will be supplied & installed by contractor. University will provide source of power only.
6. The air conditioners to be installed at the server room at the first floor of Administrative building.
7. The undersigned reserves the right to accept or reject any tender without assigning any reason thereof.
8. Any deviation of terms and conditions shall invite cancellation of Quotation/Tender/Bills etc. and forfeiture of security deposit.
9. Each firm must have GST registration, Trade License, Income Tax Clearance certificate, PAN Card and Authorized Dealership Certificate. A Self-attested copy of the above mentioned documents must be submitted along with the Quotation.
10. In case there is no approved rate of any item, the supplier have to supply the same at reasonable prices but not more than the Maximum Retail Price/market price whichever is less.

In case lowest rate is quoted by one firm for some items and by other firms for other items then the firms will have to give the willingness/consent letter to supply any or all of the materials as above as per approved rates of the undersigned.
