Rules for the Judicial Examination Training Programme

- 1. Students shall make sure before taking admission to training programme that, they are willing and able to join. Participation in the training programme is not compulsory it is purely optional
- 2. No academic benefits (academic leave, special marks, grade etc.) will be given to students in their regular BALLB course
- 3. Read carefully the instructions given in the forms and fill it accordingly
- 4. Fees once paid shall not be refunded
- 5. Admission once confirmed students are not allowed to cancel/withdraw their admission
- 6. Prepared mentally and physically before taking admission in the training programme
- 7. The training programme will be scheduled for six months. Once admission confirmed you must follow the instructions of convenor and attend the classes regularly as per time table
- 8. Certificate of completion will be given only after completion of 75% attendance in the regular classes
- 9. Provided that, in the exceptional circumstance the students are allowed to withdraw their admission and refund of fees only after two days of training programme i.e. during the orientation programme. If they feel, they are not ready/fit/competent/mentally and physically able to crack/clear the judicial examination in their respective state. Once classes started the admission will not be withdrawn and fees shall not be refunded
- 10. The withdrawal of admission as per point 9 shall be processed through convenor of the training programme by stating the above mentioned reasons
- 11. No students will be forced to take admission in this training programme and for the reason please ensure and confirm your ability before taking the admission
- 12. Any grievance shall be addressed first to convenor of the training programme
