- 3. The interested parties are requested to submit the technical bid and financial bid. The bids in Sealed Envelope-I containing "Technical Bid" and Sealed Envelope-II containing "Financial Bid" should be placed in a third sealed Envelope, with the superscription "Tender for pandal, sound, light and decoration for convocation of NLUJA, Assam " should reach the office of the Registrar, NLUJA, Assam, by 12:0 Noon on or before 17-12-2022. The Technical bid and Financial bid will be opened on the same day at 01:00 P.M. However, Financial bid will be opened subject to technical scrutiny and evaluation thereof. It is to be noted that nature and value of work experience will be duly scrutinized.
- 4. The Firm will have to deposit Earnest money of Rs. 50,000/- each in the form of Demand Draft favouring Registrar, National Law University and Judicial Academy, Assam.
- 5. The Firm to whom work will be allotted will have to execute a bond/undertaking as per rules.
- 6. The undersigned reserves the right to accept or reject any tender without assigning any reason thereof.
- 7. Any deviation of terms and conditions shall invite cancellation of Quotation/Tender/Bills etc. and forfeiture of security deposit.
- 8. Each Firm must have GST Registration, Trade License, Income Tax Clearance Certificate, PAN Card. A copy of the same must be submitted along with the Quotation/Tender.
- 9. Bills must be submitted along with necessary work order and a copy of Challan etc. within seven days from the date of delivery of goods for payment otherwise no payment shall be made.
- 10. The rate in totality of all items will be considered while awarding the work contract.
- 11. In case there is no approved rate of any item, the supplier have to supply the same at reasonable prices but not more than the Maximum Retail Price/market price whichever is less.
