### **7 DAYS CERTIFICATION COURSE ON INSOLVENCY AND BANKRUPTCY LAWS IN INDIA**

The centre for advanced research in corporate law organised a 7 Days Certification Course On Insolvency And Bankruptcy Laws In India between 14<sup>th</sup> October 2023 and 20<sup>th</sup> October 2023 in collaboration with Chambers of Abhinav Mishra and affiliated by Insolvency and Bankruptcy Board of India (IBBI). The course spanned over more than 27 hours of instruction and also included a compulsory assessment at the end.

The course was delivered in both online as well as offline modes and a total of 198 students, professionals and academicians registered and attended the course. The course instructors delivered their lectures in offline mode from the campus of NLUJA, Assam. The course was delivered through an introductory session, followed by 11 instruction sessions of more than two hours each, an assessment session and a valedictory ceremony. The course instructors included some of the well known IBC practitioners of the country and included partners of reputed law firms, practicing advocates, senior advocates, practicing company secretaries, chartered accountants, etc and included names like Adv. Bishwajit Dubey (Ex CAM), Sr Adv Arvind Nayar (Delhi HC), Adv Gauhar Mirza (CAM), Adv Sandeep Aole (Vidhi Partners), Sr Adv Rajkumar Rao (Delhi HC), Mr. Keval Seth (CA) among others.

The centre took Live Law as media partner and the top 5 performers of the assessment test were awarded with free subscription of IBCLaws.in website.

The valedictory ceremony was attended by Dr. Rajeev Mani, Additional secretary, Department of legal affairs, Ministry of law and Justice, who is also an ex-officio member of the governing body of Insolvency And Bankruptcy Board Of India.
