Terms and Conditions:

- 1. The rates should be quoted as shown against the items/works should be inclusive of all GST/taxes applicable at any point of time.
- 2. Quotation shall be submitted in a sealed envelope super scribed as "Quotation for providing Pesticide Services" and should contain the following documents:
 - a. Copy of updated Trade License;
 - b. Copy of GST Registration Certificate;
 - c. Copy of PAN Card;
 - d. Income Tax Clearance Certificate;
 - e. Experience details;
 - f. Sealed and signed copy of the Notice Inviting Quotation as acceptance of the terms and conditions mentioned therein.
 - g. Quotation for pest control services as per format in Annexure-I.
- The Quotationer/Tenderer will have to deposit Earnest money of Rs. 5000/- in the form of Demand Draft in favour of Registrar, National Law University and Judicial Academy, Assam. The EMDs will be released after finalization of bid selection process. However, EMD in respect of the successful bidder will be retained as Security Deposit till completion of contract period.
- 4. Prospective bidders should have their registered office at Kamrup/Kamrup (Metro).
- 5. The contractor shall also supply the requisite workforce with means and materials as well as tools, spares, appliances, machines, implements, vehicles for transportation etc. required for proper execution of work.
- 6. In the event of any breach of the terms and conditions by the contractor, National Law University and Judicial Academy, Assam will have full power to adopt any course of action as the same may deem fit and appropriate to the interest of the National Law University and Judicial Academy, Assam which may include penalty.
- 7. The rate of each service shall remain constant during contract period.
- 8. This contract may be renewed based on satisfactory performance of the contractor.
- 9. The contractor will be responsible for the safety of the workforce engaged and should not deploy any minor to work.
