- 1. Replacing of existing media elements with new media elements.
- The vessels are situated in two different locations at the top of G+5 Buildings.
- 3. The media elements should be carried to the vessels by the staircase only by the party.
- 4. The changed media should be carried to the ground by the party.
- Any damages to the water filtration system during the work should be repaired/replaced by the party.
- 6. The work should be carried out in presence of NLUJAA officials.
