3. Sample of Table Calendar, Diary and Paper Bag need to be submitted with the quotation. Delivery of items should be completed within 15 (fifteen) days after receipt of supply order.
4. Firm/Vendor will have to deposit earnest money of **Rs. 5,000/-** in the form of Demand Draft in favour of Registrar, National Law University and Judicial Academy, Assam. The EMDs will be released after finalization of bid selection process. However, EMD in respect of the successful bidder will be retained as Security Deposit till completion of work.
5. Each firm must have **GST registration, Trade License, Income Tax Clearance certificate, PAN Card**. A copy of the same must be submitted along with the quotation.
6. The work may be allotted to one or more supplier depending upon the urgency of the work, time factor, quality of items/works and past records of the firm for doing the works in due time.
7. Any firm/vendor indulging in any malpractice or adopting any unfair means will be barred for any work with the University.
8. The work will be cancelled anytime if the quality of supplied materials is not as per standard or the order is not supplied on time and the security deposit will be forfeited.
