IMPORTANT INSTRUCTIONS FOR CANDIDATES

General Instructions for all applicants of Ph.D. including those who have qualified UGC NET/ JRF, SLET / M.Phil. or officiating as Judge

1. All Candidates are provisionally considered for admission for the Ph.D. programme on the basis of information furnished in the application form submitted by candidates. The eligibility of all candidates for admission in PhD will be verified at the time of Document Verification. Appearing in the admission test will not vest any right on the candidates for claiming her/his eligibility in fulfilling the criteria.
2. If at any stage during the selection process and/or even after admission, if it is found that any information furnished in the application form is false / incorrect or if according to Research Committee of NLUJA, Assam, the candidate does not satisfy the eligibility criteria for the admission, her/his candidature will be cancelled.

Instructions to candidates appearing for Ph.D. Admission Test to be held on March 01, 2021 from 10:30 p.m. to 1:30 p.m.

1. As a precaution for COVID-19, the candidate must reach NLUJA, Assam by 9.30 am
2. No candidate shall be permitted to enter after the Gate Closing Time, i.e 10.40 am.
3. Candidate shall be permitted to leave the Examination Hall **for washroom break only** after 11.30 am. No Candidate shall be permitted to leave the Examination Hall before 12 noon.

4. On completion of the examination, please wait for instructions from Invigilator and do not get up from your seat until advised. The candidates will be permitted to move out one at a time only.
5. All candidates are required to download and carefully read the Instructions and Advisory for COVID-19 and strictly adhere to them.
6. No Candidate would be allowed to enter the Examination Centre, without Admit Card, Valid ID Proof and proper frisking.
7. Candidates are advised to carry only the following items with them into the examination venue: **a) Hall Ticket along with Self Declaration (Undertaking) downloaded from the NLUJA, Assam website (a clear printout on A4 size paper) duly filled in.**
 - A simple transparent Ball Point Pen
 - Personal hand sanitizer (50 ml)
 - Personal transparent water bottle
8. Candidate must carry “Any one of the original and valid Photo Identification Proof issued by the government” – PAN card/Driving License/Voter ID/Passport/ Aadhaar Card (With photograph)/ E-Aadhaar/ Ration Card./ Aadhaar Enrolment No. with Photo. All other ID/Photocopies of IDs even if attested/scanned photo of IDs in mobile phone will NOT be considered as valid ID Proof.
9. Candidates are NOT allowed to carry any personal belongings including electronic devices, mobile phone and other banned/ prohibited items to the Examination Centre. Examination Officials will not be responsible for safe keep of personal belongings and there will be no such facility.
10. No Candidate should adopt any unfair means or indulge in any unfair examination
11. Candidates are advised to check updates on NLUJA, Assam website regularly.

ADVISORY FOR CANDIDATES REGARDING COVID-19

NLUJAA will implement Social Distancing measures as per Government of India guidelines in current scenario of COVID-19 to ensure health & safety of the candidates. Adequate measures are implemented for safety of all without compromising the high standards, sanctity, and fairness in conduct of the examination. Candidates are also required to adhere to guidelines and new process for Social Distancing and hygiene to ensure safety & health of their own and fellow candidates. For safety purposes, NLUJAA strongly advises candidates not to bring anything other than permitted items.

However, in case of unavoidable situation, there will be arrangement to store bags at centres at owner's risk.

Preparation at centre:

1. Standard Operating Procedures for implementing safety precautions and for maintaining required standard of hygiene are getting implemented.
2. Before commencement of test, Seating Area will be thoroughly sanitized . All door handles, staircase railing, lift buttons, etc. will be disinfected. Wheelchairs (if present at the venue) will be disinfected.
3. Gap between 2 seats will be maintained as per GOI guidelines.
4. Hand Sanitizer will be available at entry and inside the exam venue at various places for candidates and centre staff to use.
5. The endeavour is that all the processes are touch free to ensure Social Distancing norms.
8. Candidate to reach centre as per the Reporting/Entry time to avoid any crowding at the venue at the time of entry and to maintain social distancing.

Pre-Exam Preparation

1. Candidate to check Reporting/ Entry time at Centre given in the Admit Card and to reach centre as per Reporting time only to avoid any crowding at the centre at the time of entry and to maintain social distancing.
2. Candidates will be permitted to carry only certain items with them into the venue: •Exam related documents (Admit Card, ID card, etc. Please refer Admit Card for more details) •A simple transparent Ball Point Pen •Additional photograph, to be pasted on attendance sheet •Personal hand sanitizer (50 ml) •Personal transparent water bottle

At the time of Entry

1. Candidates need to maintain a space of at least 6 feet from each other at all the time.
2. Seating layout will not be displayed outside the centre to avoid any crowding at any one place in any situation.
3. Candidates will be required to sanitize hands by washing with soap and with Hand Sanitizer before entry in centre. Hand sanitizer will be available at various locations in the centre.

IMPORTANT INSTRUCTIONS FOR CANDIDATES

1. Do not bring prohibited items to exam centre as there are no arrangements available for safe keeping your belongings.
2. At time of entry, the filled in Undertaking, and body temperature (using Thermo Guns) will be checked and centre staff will guide you to the examination halls .Candidates are required to strictly adhere to instructions provided by centre staff.
3. Please observe that no-one will be denied permission to appear for examination, until he/ she violates the covid-19 directives/advisories of Government (Central/State)
4. No TA/DA will be provided to candidates who would appear for the admission test
5. Do not carry any electronic or any other gadgets, mobile phone, tablets, pen drives, Bluetooth devices, watch, calculator, notes, loose sheets or recording instruments inside the Examination Hall.
6. Before appearing for the admission test, candidates should read all the above instructions carefully and ensure that they fulfil all the eligibility criteria for the admission in Ph.D. as per the notification dated 21.01.2021 (copy of the notification dated 21.01.2021 is place in the admission notification section of our website www.nluassam.ac.in for ready reference).
7. Candidates having symptoms of fever, cough, and cold would be made to sit in a separate isolation room/place with adequate safety measures.
