1. COURSE OBJECTIVES

Course is so designed to acquaint the students with the comprehensive knowledge of administrative law operating in India as well as in other countries such as United Kingdom (UK), United States of America (USA) and France. The students are motivated to learn about administrative law in its historical perspective so that they develop an understanding of the reasons behind the emergence of administrative law in India.

The students will make comparative studies on the basic principles of administrative law - *Rule of Law* and *Separation of Powers* prevalent in India, UK, USA and France. This will enable the students to know about the practical application of these basic principles.

Administrative law is an integral part of the Constitutional law of India, reflecting it and also shaping it. Thus, students are required to study the relationship between administrative law and the Constitution of India.

With the advent of welfare state, there has been prolific growth in the powers of State operations all round the world including India. The increase in the functions of the administration is one of the important aspects of study under administrative law. The power conferred upon the State and its instrumentalities in performing their administrative functions, especially the delegation of rule-making power have been abused and misused. In this context administrative law as a branch of law has developed certain mechanisms to regulate the excessive and arbitrary exercise of power by the administrative agencies. Students will be required to study about the administrative actions and control mechanisms evolved to regulate arbitrary exercise of power by the executive in India.

Students will be made to understand the importance and impact of the enforcement of the principles of *Natural Justice*, *Rule of Law and Judicial Review of administrative action* which is necessary to materialize the Constitutional mandate of liberty, equality and socio-economic justice in India.

The course will also emphasize upon the detailed study of different means for enforcing public accountability and transparency of the State and its instrumentalities such as institution of *Ombudsman*, *Lokpal and Lokayukta*, *Right to Information and trend of Public Interest Litigation*.

Administrative law primarily unfolds through judicial decisions hence the course furnishes extensive case materials and judicial references for developing among the students an understanding of the principles of administrative law evolved by the judiciary in India.

2. TEACHING METHODOLOGY

For teaching administrative law in the National Law University and Judicial Academy, Assam lecture method along with alternative and supplementary strategies for effective teaching will be utilized such as permissive style of teaching, brain storming, group discussion, seminar presentation (project topic). There will be lectures, classroom discussions, audio visual presentations. Surprise tests will be conducted by the course instructor frequently. Multiple Choice Questions will also be solved after completion of certain modules.

The class discussion will revolve around these Case laws and problem based. The mid-term and the final exam will also be based on these reading materials. In addition to the Cases and Materials supplied for the reading, the students are free to refer to any textbook on the Indian Evidence Act, 1872 as they deem appropriate There will be participatory teaching with discussion on basic principles, concepts, doctrines and judicial decisions relating to administrative law. To develop an understanding on varied topics of administrative law group discussion and brainstorming sessions will be held in the classroom. To encourage self study, individualized instruction and to inculcate study attitudes individual project topics are allotted to students in advance. The students prepare their topics from the list of sources suggested to them under the supervision of the teacher-in-charge of the subject. In the classroom every student is required to present his/her project topic through seminar presentation and to have his/her doubt cleared through discussion. Through project work students are encouraged to do independent research on their project topics and thereby trained to prepare good research papers/articles. The teacher will guide the students in their pursuit of legal learning through application of the planned teaching

processwhich includes introduction of the basic concept, presentation and discussion of the subject-matter in details, recapitulation on the topic discussed through questioning, clarification of doubts and queries, if any, and suggestions for further readings. The topics will be taught through projected teaching aids like power point presentation and white board.

3. Course Outcomes

- On completion of the Course the students are expected to understand the nuances of each module and thereafter they shall be in a position to undertake litigation relating to the public administration in India
- Students will be in a position to undertake comparative studies on varied issues of administrative law. Students will get acquainted with the working of tribunals
- The study of administrative law will improve the knowledge-base of the law students and encourage them to pursue administrative law as a subject of specialization at the master (LL.M.) and Ph.D level
- The course on administrative law will also enhance the competitive credentials of the law students for public service and judicial examinations in future.

4. Course Evaluation Method
