Candidates who have been allotted seats at NLUJA, Assam are required to transfer **Rs. 69,750/-** (**Rs. 27,250/-** for candidates **who do not** opt for **Hostel & Mess Facility** of the University) as **Admission Fee** for Semester I through payment link provided **on or before 21/8/2021 (2.00 pm)**. (*Admission Fee for Semester II will have to be deposited at the commencement of the same*)

**Note:**

- 1. Candidates claiming seats in the reserved category are to submit Caste Certificates/Permanent Resident of Assam Certificate (PRC)/PWD Certificate/ OBC/MOBC (NCL) Certificate whatever applicable.***
- 2. Candidates who have not paid the seat booking fee of INR 50, 000/ to the account of the CLAT Consortium, are to pay INR 1, 19,750/ ( INR 77,250/ for candidates who do not opt for Hostel & Mess Facility of the University) to the University.***

***3. Candidates who are not able to submit any document (specified by the CLAT Consortium/NLUJA, Assam) will have to submit an Undertaking, in the format prescribed by the University and appended herewith as Annexure III & VI***
