## **1. COURSE OBJECTIVES:**

There is a close relationship between Political Science and the legal studies. Both Political Science and Law constantly influence each other. Legal studies remain incomplete unless the study of Political Science is pursued in a proper way. Laws are largely shaped by the prevailing political systems. Legal structure in a society is influenced by its political environment. At the same time, the functioning nature of a political system is also affected by the prevailing legal system. Hence, it becomes imperative for the students to acquire the fundamental knowledge of political systems to understand the process and jurisprudential developments of any legal system. What is equally important for the law students is to grasp the fundamental concepts of Political Science. For a student of law, it is necessary to understand core political concepts in order to develop a critical and analytical mind. The present course has been incorporated to acquaint students with the fundamental political concepts and certain basic political theories. Besides, this course intends to introduce the students to the basic political ideas and basic theoretical framework of Political Science. With this objective, National Law and Judicial Academy, Assam has introduced this course to provide a proper understanding of vital political concepts and theories for students which are directly relevant to the legal studies.

## **2. TEACHING METHODOLOGY:**

National Law University, Assam has framed its own teaching methodology to train its students in learning and understanding of political aspects and issues. The teaching methodology is not just confined to a traditional lecture method but a participatory teaching method with an aim to discuss on various current political aspects. The pedagogy followed is the combination of lectures and intense discussions in the class.

This course requires students to engage in seminars or group discussions for which topics and themes will be assigned well in advance. Assignments will be also assigned to the students as a part of the course. The students are also encouraged to do independent research on their respective assignments. Every student is required to present their topics in the classroom and clear their doubts through discussion.

### 3. EXPECTED OUTCOMES OF THE COURSE:

On completion of the course, the students are expected to understand the nuances of each module and thereby they shall be in a position to undertake political issues with confidence in the society. Moreover, the course will also help students to have a clear understanding of the nature and functioning of various political institutions and they can also interpret them with alternative perspectives.
