Candidates who have been allotted seats at NLUJA, Assam are required to transfer **INR 1,94,000/-** (INR 2,04,000/-) as **Admission Fee** through payment link provided **on or June 20, 2023 (10:30 pm)**.

Candidates who have paid ₹20,000/- as Confirmation Fee & ₹30,000/- as Counseling Fee will pay	INR 1,94,000/-
Candidates who have paid ₹20,000/- as confirmation fee & ₹20,000/- as Counseling Fee will pay	INR 2,04,000/-
Candidates who have paid only ₹30,000/- as Counselling fee will pay	INR 2,14,000/-

- *Candidates claiming seats in the reserved category are to submit Caste Certificates/Permanent Resident of Assam Certificate (PRC) /PWD Certificate/ OBC/MOBC (NCL) Certificate, whatever applicable.*
- *Candidates who are not able to submit requisite documents (specified by the CLAT Consortium/NLUJA, Assam) will have to submit an Undertaking, in the format prescribed by the University and appended herewith as Annexure III). It is mandatory to submit all qualifying documents.*
