- After the receipt of applications, a Merit List (based on CLAT, 2024 ranking) of each Category will be published on **June 18, 2024**. Candidates who would be enlisted in the Merit List would have to deposit an amount of Rs. 2,44,000/- (for UG candidates), Rs. 2,11,500/- (for PG candidates who opt for Hostel and Mess Facility of the

University) and Rs. 1,29,500/- (for PG candidates who do not opt for Hostel and Mess Facility of the University) latest by **June 29, 2024** (3 P.M.) to avail seat at NLUJA, Assam.
