#### ✓ Minimum Requirement in Project Work:

Students must secure a minimum of **50% marks separately in the project work component** of each subject, in addition to meeting the overall pass mark requirement. Specifically:

- **Minimum 7.5 out of 15 marks** for written project submissions.
- **Minimum 2.5 out of 5 marks** for project viva-voce.

#### ✓ Provision for Students Absent in Mid-Semester Examination:

Students who are unable to appear in the Mid-Semester Examination shall be permitted to take the End-Semester Examination for a total of **75 marks (inclusive of the mid-semester's 25 marks)** , as per the modified evaluation structure.
