INTRODUCTION



This Annual Report summarizes the activities of National Law University and Judicial Academy, Assam from January 01, 2023 to December 31, 2023. It is prepared by the Executive Council for presentation to the General Council in pursuance of the requirement under Section 12 (2) (iii) (a) of the National Law University and Judicial Academy, Assam Act, 2009.

Prologue

National Law University and Judicial Academy (NLUJA), Assam stands as a pioneering institution, marking its significance as the first National Law University in the North-Eastern region of India. NLUJA, Assam's 50-acre campus in Agyathuri, Amingaon, along the Brahmaputra River, features modern infrastructure and is equipped with state-of-the-art facilities, exemplified by modern Library amenities, air-conditioned Academic Block featuring smart

classrooms, meeting rooms, faculty lounges, and specialized Research Centres, Administrative Block housed with essential offices and Conference Halls, including a Moot Court Hall designed to replicate a High Court bench. NLUJA, Assam is a member of the 'Consortium of NLUs' of the 24 (twenty-four) National Law Universities established across the country. It offers B.A., LL.B. (Hons.) Five Year Integrated Course, LL.M. One Year Degree Programme and Ph.D. Programme. The Hon'ble Chief Justice of the Gauhati High Court is the Chancellor of this University.



The session started with a welcome note by Dr. Kankana Baishya, Assistant Librarian, National Law University and Judicial Academy Assam followed by keynote address by Professor Ahuja, where he expressed his keen interest in the steps initiated by the global leading plagiarism detection service Turnitin towards curbing plagiarism in the era of artificial intelligence. The lecture highlighted the importance of academic integrity and original writing, the impact of academic integrity in education, what is ChatGPT, the role of educators in ensuring that the students' learning objectives are met, and the role of Turnitin therein. The lecture was witnessed by 251 participants including educators, scholars, students and other officials nationwide. 

7. CAMPUS DEVELOPMENT AND INFRASTURCTURE

7.1. Ongoing Projects

The second phase of campus infrastructure development has commenced with the approval of Government of Assam with financial assistance of INR 46 crores. Accordingly, the Public Works Department has started the second phase of construction of the following buildings:

7.1.1 300 Bedded Student Hostel

The construction of a 300 bedded student hostel has commenced. The 300 bedded hostel is a six floor (G+5) building with 18000 square feet plinth area. The hostel building will consist of 150 single occupancy rooms and 90 double occupancy rooms along with a separate warden's room, warden office room, visitor's lounge, visitor's room, sick room, coffee shop, student mess, common room, study room etc. Washrooms will be constructed for the students at a ratio of 1:6. There will be four staircases and four lifts for the students along with the ramp at the entrance.

7.1.2 Vice-Chancellors' Residence

The construction work for the residence of the Vice-Chancellor has started. The Vice-Chancellors' Residence is a duplex bungalow (G+1) with total area of 6250 square feet. The building will consist of four bedrooms, and a drawing cum dining room. There will be separate rooms for VC Office, caretaker, servant room, guestroom, waiting room etc. in the bungalow. The premise would also house a landscape garden.

7.1.3 Teachers' Residential Quarters

The construction of Teachers' Residential Quarters will commence shortly. The Teachers' Residential Quarters is modelled as a typical apartment building with 3000 square feet plinth area. Each quarter will be a three (03) bedroom flat with a common drawing and dining room, a kitchen, two (02) toilets and a balcony.

7.1.4 Day Care Centre

National Law University and Judicial Academy, Assam, has initiated the construction of a creche` within its campus to support working parents and provide childcare facilities. This initiative aims to create a more conducive and supportive environment for faculty members, staff, and students with young children. The creche` will contribute towards fostering a family-friendly atmosphere at the University.

7.1.5 Rain Water Harvesting Plant





University has built a Rain Water Harvesting Plant. This innovative system captures and stores rainwater, preventing it from going to waste and helping to recharge local aquifers.

7.1.6 Vermicompost Plant





The National Law University and Judicial Academy, Assam, has taken a significant step towards sustainable environmental practices by establishing a vermicompost plant on its premises. This initiative reflects the institution's commitment to environmental conservation and responsible waste management. Vermicompost is a natural and nutrient-rich fertilizer produced through the decomposition of organic waste by earthworms.

ACTIVITIES AND AMENITIES OF IT SECTION

8.1 Onboarding SAMARTH e-Gov Suite

Considering the requirement of a comprehensive ERP system to operationalise the administrative functions of its different sections on the ICT platform, University has onboarded with the SAMARTH e-Gov Suite after getting the approval from the Ministry of Education, Government of India. The Samarth, a cloud-based e-Gov suite has been initiated by Ministry of Education, Govt. of India and developed and maintained by University of Delhi. SAMARTH has 40+ modules that cater to Academic, Administrative, Accounts and Finance, HR related activities of Higher Education Institutes.

8.1.1 Deployment of Leave Management Module:

Leave Management Module has been successfully configured and deployed on Samarth Platform with multi-level recommendation and approval system. A hands-on training session on leave management was conducted for the staff members (teaching and non-teaching) on 25th and 26th July, 2023. Total 327 leave applications have been processed on this platform in the year 2023.

8.1.2 Deployment of Payroll Management Module:

Payroll Management Module has been successfully implemented with role-based functionalities like salary generation and processing, verification and approval. Pursuant to the deployment of this system, employees are able to view and download payslips as well as TDS data and also declare the income tax information at the employee portal. Further, Accounts Section can email payslips to employees in bulk and generate reports/ statements related to salary, income tax etc.

8.1.3 Deployment of Academic Module:

The Academic Module is configured and student's details have been uploaded on the SAMARTH portal. Further, result of the Semester End Examination (December 2023) has been successfully processed for the B.A.,LL.B. (Hons.) FYIC batches of 2020, 2021, 2022 and 2023 on SAMARTH.

8.2 Enhancement of CCTV System:

Considering the safety and security of the campus, 60 numbers of additional CCTV cameras have been installed at key outdoor and indoor locations that include Multi-Purpose Indoor Hall, Academic and Administrative Block, Hostels etc.

8.3 NAD and ABC

The degree certificates of the B.A., LL.B. (Hons.) FYIC (from 2013-17 to 2017-22 batches) and One Year LL.M. Degree Programme (from 2012-14 to 2021-22 batches) have been successfully published on NAD Digilocker platform. Further, total of 209 ABC accounts have been created on Digilocker for students of the University.
