Hon'ble Shri Justice J. Chelameswar, Judge, Supreme Court of India is an acclaimed judge and known for his forthrightness in upholding the constitutional values. The NLUJA is blessed to have him as the Chief Guest to deliver the first Convocation Address. I extend a hearty welcome to you Sir.

It is indeed a proud privilege for all of us in NLUJA that Hon'ble Shri Justice Ranjan Gogoi, Judge, Supreme Court of India and son of the soil is gracing the occasion as a Guest of Honour. His continued support will go a long way in building NLUJA as a prominent University. Sir, I extend a very warm welcome to you on this auspicious occasion.

Hon'ble Shri Justice Arvind Bobde, Judge, Supreme Court of India, is a great personality known in Indian judiciary and has evinced keen interest in the overall growth of NLUJA. His presence as a Guest of Honour has added an extra grace to this event. Sir, with all earnestness I extend a very warm welcome to you.

This event is made possible because of the continuous guidance and deep involvement of our beloved Chancellor, Hon'ble Shri Justice Ajit Singh, Chief Justice of Gauhati High Court. His commitment to the development of the University is unparalleled. It is in the fitness of things that his Lordship is presiding over the First Convocation of NLUJA and will confer the degrees to the graduands. Sir, it is my privilege as well as honour to extend a very warm welcome to you.

I extend a warm welcome to Hon'ble judges, judicial officers, government officers, Hon'ble members of the General Council, Executive Council, Academic Council and other bodies of the University, graduands, parents, distinguished invitees, teaching and non-teaching staff of NLUJA, students, members of the press and media and all others who have assembled over here to witness this important event of NLUJA.

On this occasion, I would like to place before the august gathering a brief report on the "Journey So Far" of NLUJA. The National Law University & Judicial Academy, Assam came into existence by a State of Assam legislation passed in 2009 and started functioning from June 2011 from a small three room apartment in Uzan Bazar near Gauhati High Court. Three months later, the University was shifted to the North Eastern Judicial Officers' Training Institute building at Ulubari. The first academic session started functioning from September 1, 2011 with first batch of sixty students for B.A., LL.B. Honours who will be taking their degrees today along with the second batch of students admitted in 2012. The University is administering B.A., LL.B. Honours (Five Year Integrated), LL.M. (One Year) and Ph.D. degree courses.

The foundation stone for the Permanent Campus of the University at Amingaon was laid by Hon'ble Shri Justice Adarsh Kumar Goel, the then Chief Justice of the Gauhati High Court and the Chancellor of the University on July 1, 2012. The permanent Campus, in a sprawling 50

acres of beautiful landscape with sylvan Hills in the backdrop and mighty Brahmaputra river flowing in the front was inaugurated on March 25, 2017 in the presence of a galaxy of distinguished quests.

Due to the fortnightly campus review meetings held by His Lordship, the Chief Justice of Gauhati High Court along with the Chief Secretary of Government of Assam, supported by a team of dedicated Hon'ble Judges of Gauhati High Court, Judicial Officers, Government Officers, PWD Engineers, our own teaching and non-teaching staff to mention a few, the campus is growing in leaps and bounds with state-of-the-art facilities.

The herculean task of building a world-class university is taken up in the right earnest by the members of the University with their hard work and dedication. I would like to mention a few milestones achieved by the University.

NLUJA has become a member of Shastri Indo-Canadian Institute (SICI) on December 7, 2016 paving way for collaborations and exchange programmes with the Canadian Universities. A Ph.D. student of NLUJA was awarded a fellowship to research for three months in Canada. The Vice Chancellor had the opportunity to pay visit to Soochow University Law School, Taipei and explore collaboration with important universities in China and Japan at their invitation on November 24-26, 2017. Efforts are on to develop collaborations with the European Universities and Universities in the U.S.

The University has entered into MoUs with the Assam Administrative Staff College on April 27, 2017, the India International Institute of Democracy and Election Management (IIIDEM), Election Commission of India, New Delhi on April 27, 2017 and IDIA Charitable Trust on May 15, 2017.

The University has established the Centre for Child Rights in collaboration with the UNICEF to study, research and promote child rights activities in Assam and the North-East. Centre for Environment Law and Centre for Disability Studies and Health Laws are also established and functioning effectively.

The University is handling the project of the Government of Assam funded by the World Bank for drafting of the legislation for the establishment of Inland Water Transport Regulatory Authority and Memorandum of Association and Articles of Association for the establishment of two companies to manage ports and vessels.

We have started Dr. Gurjeet Singh Memorial National Moot Court Competition from the academic year 2016-17 as a flagship programme of the University. "Adhwik Udjjapon" ADUJ 2017, a student national cultural fest was also successfully conducted in the same year as another flagship programme of the University. Sports Committee of Student Bar Council are busy in organising national sports festival "ABHIVEERA 2018", another flagship programme of NLUJA in this academic year.

The University is publishing two journals NLUA Law and Policy Review and NLUA Law Review (Student Journal). We are also publishing Nyayalok, six-monthly news magazine of NLUJA.

Project on "Minimum Laws" to research and systematize laws of the State of Assam is under preparation and will soon be taken up. The initiative is taken by the Chief Secretary of the Government of Assam to institute Chief Minister's Good Governance Fellowships whereunder the students of NLUJA will be posted in the Government Departments to understand their working and suggest innovations in the system. As desired by the Hon'ble Chief Minister, efforts are on to establish a Centre for Space Law Research with the assistance of ISRO which is being facilitated by Kamath & Kamath, Bangalore. One of our faculties is working in UNDP project on biodiversity laws with the help of NLSIU, Bangalore and will soon be master-trainer to train stakeholders in the North-East for conservation and sustainable development of biodiversity.

Our young and energetic faculty is actively engaged in quality teaching, research, extension and other co-curricular activities. Many of them are participating in national and international seminars and conferences. Our students are not lagging behind in participating in national and international conferences and Moot Court Competitions and have brought many laurels to the University.

The University has plans to establish a few more study and research centres, launch part time LL.M. degree programme for legal professionals and start some diploma and certificate courses in cutting edge areas of law. Preparatory work is going on in developing necessary regulations for these programmes.

Ladies and gentlemen, in the last seven years of its establishment NLUJA is carving out a niche for itself in the highly competitive world of legal academics and hopes to develop as an eminent University of national and international repute in the coming years with the kind cooperation of all of you.

In this first Convocation of NLUJA a total of 148 graduands are taking their degrees. These include 54 from the first batch (2011-2016) of B.A., LL.B., 58 from the second batch (2012-2017) of B.A., LL.B., 6 from the first batch (2012-14) of two year LL.M., 2 from the second batch (2013-15) of two year LL.M., 8 from the third batch (2014-16) of two year LL.M., 12 from first batch (2015-16) of one year LL.M. and 8 from the second batch (2016-17) of one year LL.M.

The University has instituted two gold medals one each for the highest scorer in B.A., LL.B. and LL.M. I am very happy to announce the names of the gold medal awardees in the first convocation:

#### **UNIVERSITY AT A GLANCE**

The National Law University and Judicial Academy, Assam was established by the NLUJAA Act 2009 (National Law University and Judicial Academy, Assam Act No. XXV of 2009) as the fourteenth National Law University of the country. The University envisions to provide legal education to the law aspirants with an avowed objective of building a committed, patriotic and justice (Nyaya) oriented law graduates and post-graduates who will put service before self to transform India into an equalitarian, egalitarian, democratic republic with particular focus on the North Eastern States. This mandates the University to update the curricula and pedagogy from time to time and hone professional skills among the faculty and students through moots, debates, mock trials, internships, study circles, workshops, seminars, conferences and symposia in the cutting-edge knowledge in law and justice system.



The new campus of the University at Amingaon was inaugurated on March 25, 2017 in the presence of a galaxy of dignitaries viz. Shri Sarbananda Sonowal, Hon'ble Chief Minister of Assam; Hon'ble Mr. JusticeJ. Chelameswar, Judge, Supreme Court of India; Hon'ble Mr. Justice Sharad Arvind Bobde, Judge, Supreme Court of India; Hon'ble Mr. Justice Abhay Manohar Sapre, Judge, Supreme Court of India; Hon'ble Mr. Justice Amitava Roy, Judge, Supreme Court of India; Hon'ble Mr. Justice Afit Singh, Chief Justice of Gauhati High Court and Chancellor of National Law University, Assam; and

Shri V. K. Pipersenia, Chief Secretary, Government of Assam. The inaugural function was graced by the Hon'ble Judges of Gauhati High Court, Registrar General of the High Court, Registrars and Officers of the High Court, Judicial Officers, Additional Chief Secretary, Law Secretary, DGP, DC, SP, other government officers, court officers, PWD officials, teaching and non-teaching staff, students of NLUJAA, members of the press and media.



Presently National Law University and Judicial Academy, Assam is offering the following courses:

- B.A.,LL.B. (Hons.) Five Year Integrated Programme
- LL.M. One Year Programme, and
- Ph.D.Programme

The University proposes to conduct Certificate and Diploma/Degree Courses through distance and online mode under the aegis of the various Centres established in the University for advanced legal studies and research. The Centres have been set up by the University with the intent to address the socio-legal issues and challenges specifically of the North-East region. Some of the Centres have been conducting seminars, conferences, and training programmes and research projects on research areas/target groups pertinent to NE India. The University is built on a sprawling 50 acres of beautiful landscape at Amingaon, Guwahati, which is situated on the north bank of the Brahmaputra river with an imposing hill on the other side. The campus, at present, houses the Administrative Block, Academic Block, Boys' Hostel, Girls' Hostel, Power House, and Security Barrack where all modern amenities are available. Construction of Library, Auditorium, and Staff quarters for teaching and non-teaching staff, Vice-Chancellor's bungalow are underway. The Judicial Academy has also been constructed

in the University campus, and it is one of the unique experiments in legal education in which the University and Judicial Academy have been accommodated in a single campus. The campus is naturally endowed with greenery where the students reside in close proximity with nature. To inculcate environment friendly values among students and to make them socially responsible, the University makes concerted effort towards the development and implementation of sustainable green practices.

The University has affiliation with the UGC under Section 2(f) of the University Grants Commission Act, 1956, the Bar Council of India (BCI) and the Association of Indian Universities (AIU). The University has initiated the process of its accreditation by the National Assessment and Accreditation Council (NAAC) and recognition under Section 12(b) of the University Grants Commission Act, 1956.



National Law University and Judicial Academy, Assam campus has state-of-the art infrastructure. The air conditioned Academic Block is equipped with sophisticated facilities such as customized class rooms with smart board, LCD screen, projector, spacious seating arrangements, etc. Located in the Academic Block is the Moot Court reflecting all the requirements of a regular bench of a High Court with spacious seating arrangement for 150 students for regular practice of moot and court activities. One more Moot Court Hall for conduct of various moot court competitions is available in the Administrative Block with all the modern facilities required for conducting competitions. Further, the Conference Hall situated in the Administrative Block is furnished with world-class facilities to conduct national and international conferences, seminars

and workshops. In addition, there are a number of meeting rooms, discussion lounges, faculty rooms, various Academic Centres fitted with all modern amenities in the Academic Block.

Adjacent to the Academic Block is the Administrative Block which is endowed with modern facilities and houses the Vice-Chancellor's Office, Offices of the Registrar, the Finance Officer, the Deputy Registrar and Assistant Registrars. Well facilitated Meeting Hall and Conference Hall are in the Administrative Block where meetings of Statutory Bodies and other academic and administrative functions are organised.



On the topmost floor of the building, the Library has been set up temporarily; however, the same shall be shifted to an independent customized building under construction. National Law University and Judicial Academy, Assam Library has a collection of more than fifteen thousand titles in the field of Law, Social Sciences and Humanities.





The University campus is being developed with eco-friendly systems to maintain the eco-friendly environment of the campus. Some of these measures include developing a green garden around the Administrative and Academic buildings, solar energy for street lights and other entrances of buildings, emergency power supply from solar system in the offices and hostels in case of power failure, solar water heaters for domestic purposes and plantation of evergreen Devadaru, Pine and Bakul trees along the streets inside the campus. Two hostels, one for boys and the other for girls, with single and double occupancy rooms, smoke-free kitchen, spacious dining area, reading hall, gymnasium, yoga facility and prayer hall are located in the campus.


