

PRACTICAL PAPERS

Ensuring the dissemination of knowledge beyond the classroom, the University has a unique system of continuous assessment of the research aptitude of students; a continuous system of practical assessment is conducted to enhance the same. In the first three years of the Undergraduate Degree Programme, the students are required to do research projects for each subject in each semester. In the last two years, practical papers are accorded a distinct status and are assessed separately by the external eminent subject experts, in which the practical examination becomes a combination of Moot Exercises and Research Projects.

With parallel teaching of the mandatory courses, the University also offers to its students, studying in the final year to study two specialization courses of their own choice which they can chose among the array of ten courses, viz., Business Law, Intellectual Property Law, Constitutional Law, Administrative Law, Consumer Protection Law, Environmental Law, Criminal Law, Criminal Law, Criminal Law, International Law and Human Rights. This way, all students are trained and equipped in advance before pitching into the profession of their interest having indepth knowledge and analytical skills, making them more viable to be recruited when compared to rest.

The Recruiters have the flexibility to formulate their own policies for recruitments and the same shall been communicated to the RCC.


The RCC plans to have the Recruitments in the month of August, 2015.
