#### Engagement of University Counsellor(s) (Contractual)

National Law University and Judicial Academy, Assam invites applications from qualified and experienced professionals for engagement as **University Counsellor(s)** on a **contractual basis**. The engagement shall be part-time in nature, requiring **campus visits two to three days per week**. Remuneration shall be **negotiable**, depending upon the candidate's qualifications and experience and University norms.

### 1. Essential Qualifications and Experience

- Master's Degree in Psychology, Clinical Psychology, or Counselling Psychology from a recognized University.
- Minimum of 3 years' relevant experience in counselling students or young adults in an educational institution, clinical setting, or mental health organization.
- Excellent communication and interpersonal skills, with sensitivity to student diversity and wellbeing.

### 2. Desirable Qualifications

- Registration with the Rehabilitation Council of India (RCI) or an equivalent professional body.
- Experience in conducting group therapy, stress management workshops, or mental health awareness programmes within academic environments.

### 3. Job Description

The University Counsellor shall—

- Provide psychological counselling, guidance, and support to students on academic, emotional, or personal issues.
- 2. Conduct individual and group sessions for stress management, time management, and coping with academic pressure.
- 3. Maintain confidentiality and records of counselling sessions as per professional ethics.
- 4. Assist the University in organizing mental health awareness and wellness initiatives.
- 5. Submit periodic reports to the designated University authority regarding overall trends and recommendations, without disclosing personal details of students.
- 6. Visit the campus 2–3 days a week, as per a schedule mutually agreed upon with the University administration.

#### 4. Tenure and Remuneration

- The engagement shall be **contractual**, initially for a period of **one year**, extendable based on performance and institutional requirements.
- Remuneration shall be negotiable, commensurate with qualifications and experience.
