1. Designation and Number of Posts:

2. Qualification:

A. Research Associate (03 Posts)

An individual who:

- i. possesses LL.M. / Master’s Degree in Law, Social Sciences, Public Policy, Disability Studies, or allied disciplines with minimum 55% marks (or equivalent grade); and
- ii. demonstrates strong research, analytical and drafting skills.

Desirable:

Experience in empirical research, field-based studies, policy analysis, or familiarity with the Rights of Persons with Disabilities Act, 2016.

B. Research Assistant (03 Posts)

An individual who:

- i. possesses LL.B. / Master’s Degree in relevant discipline with minimum 55% marks (or equivalent grade); and
- ii. demonstrates competence in research, documentation and report drafting.

Desirable:

Experience in data collection, surveys, institutional studies, or disability rights frameworks.

C. Data Entry Operator (01 Post)

An individual who:

- i. is a Graduate in any discipline from a recognized University;
- ii. possesses proficiency in MS Office and data management tools; and
- iii. has at least one year of relevant experience in data entry/documentation work.

D. Junior Administrative Assistant (01 Post)

An individual who:

- i. is a Graduate in any discipline from a recognized University;
- ii. possesses experience in office administration, file management and official correspondence; and
- iii. has working knowledge of computers and office software.

3. Nature and Tenure of Engagement:

The engagement shall be purely contractual and co-terminus with the duration of "Project Ability Empowerment." The appointment shall not confer any right for regular appointment or continuation beyond the project period.
