2. The sealed envelope should bear the following 'superscription' on the top:

3. Sample of cloth (minimum 1/2 mtr.) need to be submitted with the quotation. Delivery of items should be completed within 15 (fifteen) days after receipt of supply order.
5. Quoted rate for Shirt, Pant, Saree and Blouse should be inclusive of stitching charges.
6. The Quotationer/Tenderer will have to deposit Earnest Money of **Rs. 5,000/-** in the form of Demand Draft favouring Registrar, National Law University and Judicial Academy, Assam. The EMDs will be released after finalization of bid selection process. However, EMD in respect of the successful bidder will be retained as Security Deposit till completion of work.
7. Each Firm/Individual/Tailor must submit GST Registration Certificate, Trade License, PAN Card, Income Tax, Clearance Certificate. A copy of the same must be submitted along with the Quotation/Tender.

11. Quality of samples along with price quoted will be considered in the screening process.


