## NOTICE INVITING QUOTATION FOR EMPANELMENT OF VENDORS FOR SUPPLY OF SPORTS GOODS AND EQUIPMENT

This notice invites quotations, affixed with non-refundable Court Fee Stamp of Rs. 8.25/-, for selection of vendors for supply of **Sports Goods and Equipments**, enclosed at **Annexure – I**, to the National Law University and Judicial Academy, Assam, for the financial year **2026-27** w.e.f. 01-04-2026 to 31-03-2027. The same will be received at the office of the Registrar, NLUJA, Assam during office hours on or before **March 13, 2026 (01:30 PM) and will be opened on the same day at 02:00 PM.** The Quotationer/Tenderer or their authorized agents may remain present at the time of opening of the quotations.

### **List of items is enclosed at Annexure - I (Sports Goods and Equipments)**

#### Terms and Conditions:

1. The rates should be quoted as shown against the items/articles and should be inclusive of GST/taxes applicable at the time of submission.
2. The sealed envelope should bear the following 'superscription' on the top:  
"The Registrar, National Law University and Judicial Academy, Assam".
3. The Quotationer/Tenderer would have to deposit Earnest Money of **Rs. 5,000/-** in the form of Demand Draft in favour of Registrar, National Law University and Judicial Academy, Assam. The EMDs will be released after finalization of bid selection process. However, EMD in respect of the successful bidder will be retained as Security Deposit till completion of contract period.
4. The duly selected Quotationer/Tenderer will have to execute a bond/undertaking as per University rules, prior to empanelment with the University.
5. The undersigned reserves the right to accept or reject any tender without assigning any reason thereof.
6. Any deviation from the prescribed terms and conditions shall invite cancellation of Quotation/Tender/Bills etc. and forfeiture of security deposit.
7. Each Firm must have GST registration, Trade License, Income Tax Clearance Certificate, PAN Card. An attested copy of the same must be submitted along with the Quotation/Tender.
8. Preference will be given to vendors with prior experience in supplying sports items to National Law Universities or other higher educational institutions.
9. Each firm must have registered office at Kamrup Metro or Kamrup.
10. Bills must be submitted along with necessary work order and a copy of Challan etc. within seven days, from the date of delivery of goods for payment, otherwise no payment shall be made.
11. The supply order may be issued to one or many suppliers depending upon the urgency of the work, time factor, quality of works and past record of the firms in respect of delivery of goods within due time.
12. In case there is no approved rate for any item, the supplier has to supply the same at reasonable price but not more than the Maximum Retail Price/market price, whichever is less.
13. In cases where the lowest rates for identical or comparable items are quoted by different firms, such firm shall be repaired to furnish their willingness (along with consent letter) agreeing to supply any/all of the items, as may be allotted, at the approved lowest rates finalized by the undersigned/competent authority, Further, in the event that the lowest quoted rate for any items exceeds the prevailing MRP or regional market price, payment shall be restricted to the MRP or prevailing market price whichever is lower.
14. Any firm/supplier indulging in any form of malpractice or adopting any unfair means will be barred from working with the University.
15. The contract will be cancelled at anytime, if the quality of supplied materials is not as per standard or the order is not supplied on time, and the security deposit will be forfeited.
16. Past record of the firms/suppliers/contractors will be duly considered while awarding the work.
17. Selection criteria may include any other condition deemed to be just, fit and proper at the time of technical/financial scrutiny.
