## NOTICE INVITING QUOTATION

Sealed quotations affixed with non refundable Court fee stamps of Rs. 8.25 (Rupees Eight and Twenty-Five paise) only are hereby invited from reputed firms/agencies/individuals for **Pest Control Services** for a period of one year at National Law University and Judicial Academy, Assam, as per the following details and terms & conditions given below, which will be received at the office of the Registrar, NLUJA, Assam during office hours up to **01:30 PM** on or before **September 16, 2024** and will be opened on the same day at **02:00 PM**. The Quotationer/Tenderer or their authorized agents may remain present at the time of opening of the quotations.

### **Terms and Conditions:**

1. The rates should be quoted as shown against the items/works and should be inclusive of GST/taxes applicable at any point of time as per format in Annexure-A.
2. The sealed envelope should bear the following 'superscription' on the top:  
"The Registrar, National Law University and Judicial Academy, Assam".
3. The Quotationer/Tenderer will have to deposit Earnest money of **Rs. 5000/-** in the form of Demand Draft in favour of Registrar, National Law University and Judicial Academy, Assam. The EMDs will be released after finalization of bid selection process. However, EMD in respect of the successful bidder will be retained as Security Deposit till completion of contract period.
4. **Each Firm must have GST Registration, Trade License, PAN card, Labour License, ESI & EPF Registration Certificate, Income Tax Clearance Certificate, Experience details etc. An attested copy of the same must be submitted along with the Quotation/ Tender.**
5. Prospective bidders should have their registered office at Kamrup/Kamrup (Metro).
6. The contractor shall also supply the requisite workforce with means and materials as well as tools, spares, appliances, machines, implements, vehicles for transportation etc. required for proper execution of work.
7. In the event of any breach of the terms and conditions by the contractor, National Law University and Judicial Academy, Assam will have full power to adopt any course of action as the same may deem fit and appropriate to the interest of the National Law University and Judicial Academy, Assam, which may also include penalty.
8. The rate of each service shall remain constant during contract period.
9. This contract may be renewed based on satisfactory performance of the contractor & subject to approval of authority.
10. The contractor will be responsible for the safety of the workforce engaged and should not deploy any minor to work.
11. It is to be clearly understood by the contractor that the contract is purely a commercial engagement and is not an employment. There will be no employer-employee relationship between National Law University and Judicial Academy, Assam and the contractor's employees. Immediately on termination of this contract, the contractor shall be obliged to withdraw all its from the said premises of work.
12. The contractor shall be liable for any damage or compensation payable in accordance with the law in respect of or in consequences of any accident or injury to any workmen or other person in their employment as per the provision of the Workmen Compensation Act.
13. Payment will be made on quarterly basis and bills to be submitted along with the service report.
14. Payment shall be released within 15 days from the date of receipt of bills and after satisfactory completion of service.
